



## **BYBC Young Dancer Workshops**

BYBC believes every child should have an opportunity to learn to dance . . .

Starting this December, and continuing on a regular basis, BYBC will host a series of dance workshops throughout the community. These workshops will be free of charge and open to children ages 6 – 11, with the goal of providing a unique opportunity for children that would typically not be able to attend dance classes.

Each workshop day will include a variety of dance styles, including, but not limited to -- ballet, musical theatre, contemporary, jazz and hip hop. Every dancer workshop day will be a little different, and children may attend as many as they would like, provided that they register for each event.

Young Dancer Workshop instructors are master teachers that have expertise working with children.

### **Program Guidelines:**

- Classes are for boys and girls, ages 6 – 11.
- It is preferred that participants have little or no prior dance experience.
- Registration is required, including written approval of a parent or legal guardian.
- Participants must attend workshops accompanied by an authorized adult.
- Due to space limitations, we ask that no more than one adult accompany each participant.
- Participants should wear comfortable clothes. Dance shoes are not required.
- BYBC will provide water and some snacks; however, participants are encouraged to bring their own healthy snacks and water.
- Students can participate in as many workshop days as they like, provided that the participant is registered for each event, and BYBC is able to accommodate space, etc.
- Participants that join the Young Dancer Workshop mailing list will be notified of upcoming events.

The undersigned represents and agrees that this waiver and release is binding not only on the undersigned, but also upon their respective heirs, representatives, administrators, executors, and assigns. This release covers every possible injury or accident of every sort and nature, whether related to the permitted activity, the equipment, the condition of the premises, or otherwise, and regardless of whether due in whole or in part to the negligence of a Releasee or other Participant.

In addition, if any anyone (whether a Participant, minor Participant's Parent/Legal Guardian, or anyone else on behalf of a Participant or Parent/Legal Guardian) makes a claim against any of the Releasees despite their release, then the undersigned agree to indemnify and hold harmless, each of the Releasees from any litigation expenses, attorney fees, loss, liability, damages or cost any Releasee may incur as the result of any such claim.

The undersigned represent that the Participant is healthy and has no physical or mental condition that would impair Participant's ability to fully and safely participate in the contemplated activity.

A Chaperone/Adult (age 21 or older) is required to attend with participants. This Chaperone will be responsible for the participants at all times. Burbank Youth Ballet Company is not responsible for participants' supervision.

I understand that Burbank Youth Ballet Company, from time to time, produces promotional and other materials relating to its programs. I understand that as a participant in and/or a spectator at the Young Dancer Workshop, the Participant may be included in videotapes, DVDs, podcasts, videocasts and/or photographs taken during the Event. Therefore, without reservation or limitations, I, in my own behalf and on behalf of the minor Participant, hereby assign, transfer and grant to Burbank Youth Ballet Company, its successors, assignees, licensees, sponsors, any media, and all other commercial exhibitors the exclusive right to photograph and/or videotape the minor Participant and to utilize such videotapes and photographs and Participant's name, face, likeness, voice and appearance, in advertising and promoting the Event or in advertising and promoting future events, and for sale for any and all purposes.

I further understand that neither Burbank Youth Ballet Company nor any third party is under and obligation to exercise any of the foregoing rights, licenses and privileges. The intent of this document is to relieve the Releasees to the fullest extent permitted by law of any responsibility or liability for injury or damage arising out of the contemplated activity. As a consequence, if any term or condition in this document is determined by any court of competent jurisdiction to be overbroad or otherwise unenforceable for any reason, then the undersigned stipulate and agree not only that the remainder should be enforced, but also that the otherwise unenforceable term should be reformed and enforced to the fullest extent permitted by law.

I, in my own behalf and on behalf of the Participant, hereby warrant that I have read this form in its entirety and fully understand its contents and are voluntarily signing the same.
